Schedule I, Part I, Line 2 - The Coalition screens clients by determining if the cat(s) to be altered are owned or feral. Feral cat surgeries are exempt from income requirements. For domestic cat owners, we screen for low-income by asking if the clients or their minor children receive any kind of public assistance (food stamps, Medicaid, welfare, AFDC, housing assistance, SSI, etc.) OR if their income is within the WIC guidelines (see below). If they qualify, we sign them up for a clinic or provide them with a voucher for their cats. Otherwise, we refer them to several of the most affordable veterinarians in our area. WIC Guidelines are as follows: for a family of 1, the client must earn less than \$20,665; for a family of 2, the client must earn less than \$27,991; for a family of 3, the client must earn less than \$35,317; for a family of 4, the client must earn less than \$42,643; for a family of 5, the client must earn less than \$49,969; for a family of 6, the client must earn less than \$57,295. For clinics, the Coalition collects client donations that are immediately put toward payment for services rendered, augmented by Coalition support, which is paid at the time of service by means of a check from the Coalition's bank account. For vouchers, the Coalition sends a voucher to the client, and the client donation for discounted services rendered is paid directly to the vet at the time of service. The Coalition receives a billing from the vet detailing the services rendered, donation amount, and residual payment required. All records are entered into money management software and financial reports are generated quarterly or upon request.
